

RECALL OF MEETING #2021-11

The November meeting of MIFDI was held on Wednesday, November 17, 2021 hosted by the Wayland Fire Department courtesy of Chief Neil McPherson.

The training program was provided by Bob Mitchell of Mitchell Associates. Bob conducted a very informative power-point presentation on the proper design of a PPE decon area and work uniform laundry facilities for firehouses. Bob also shared some important tips in regards to reducing cross-contamination as a result of firefighting and EMS incidents.

Members were provided with copies of a publication titled "HEALTHY IN/HEALTHY OUT" outlining the best practices for reducing firefighter risk of exposure to carcinogens.



EMS Run

Hospitals are FULL

In most hospitals throughout the Commonwealth beds are at full capacity, and not with covid patients. It appears that many sick patients have put off surgeries and other medical treatments during the pandemic and the delay in care has caused their conditions to worsen. Some hospitals have postponed minor procedures to free up beds for more serious cases. Patients are also occupying beds longer because they are now sicker.

To make matters worse, some hospitals are also dealing with a shortage of nurses since many have left the nursing profession due to "burnout" during the pandemic.

This situation with hospitals can place a strain on the EMS system due to delays in the ER as crews are standing by waiting for a bed. There is also an increase in hospital transfers by EMS providers due to hospitals unable to provide emergency procedures for those most critical.

Our EMS incidents have seen a significant increase over the past two years with little sign of this trend turning around. We are seeing a lot more ambulance mutual aid to other communities due to multiple EMS runs. Some temporary solutions include manning an additional ambulance during peak periods with members on overtime funded through the EMS revenue account. Other options are to staff an "EMS Fly Car" with a medic and basic in an SUV to free up fire companies waiting on ambulances. Hopefully the covid numbers will continue to decline in 2022 to relieve this burden overwhelming our EMS system.

Assistance to Firefighters Grants Program

Assistance to Firefighters Grants

The primary goal of the Assistance to Firefighters Grant (AFG) is to meet the firefighting and emergency response needs of fire departments and non-affiliated emergency medical service organizations.

Since 2001, AFG has helped firefighters and other first responders obtain critically needed equipment, protective gear, emergency vehicles, training and other resources necessary for protecting the public and emergency personnel from fire and related hazards.

FY20 AFG Funding

As of Sept. 21, 2021, FEMA has made 1,887 awards totaling \$319.5 million.

GRANT PPLICATION PERIOD: 11/8 - 12/17/2021 at 5PM ET
