

MARCH MEETING

The next meeting of MIFDI will be held on <u>Wednesday, March 27, 2019</u>. We will be hosted once again by the Natick Fire Department, 22 East Central St. (Rt.135) courtesy of MIFDI member Captain Eugene Rothman, Natick Fire Training Officer. MIFDI last met in Natick for our October 2017 meeting.

The training will be provided by Mary Dozois, Supervisor for the Commonwealth of Massachusetts Department of Labor Standards. Mary's presentation will focus on the recent adoption of National OSHA Regulations and the affect it will have on the fire service. She will address the 4 major topics that OSHA is commonly watchful for within fire departments. As Training and Safety Officers, this is a very important program that we must have knowledge on to address potential issues or violations within our department.

SCHEDULE: 0930 Coffee, 1000 Presentation, 1130 Business Meeting, 1200 Lunch (off site).

DIRECTIONS: From Rt. 128/I 95 take Rt.9 WEST in Wellesley to Rt.27 SOUTH in Natick. Continue SOUTH on Rt.27 for 3-traffic lights, that will be Rt.135. Turn left on Rt.135 to the second left, that is Clarendon St which brings you to the parking lot in the rear of the Public Safety Bldg.

From the Mass Pike (I 90), Take EXIT 13 to Rt. 30 EAST. Follow Rt.30 to Rt. 27 (3-lights). Turn right on Rt.27 SOUTH to Rt. 135. Turn left on Rt.135 EAST to the second left which is Clarendon St. which brings you to the parking lot in the rear of the Public Safety Bldg.

RECALL OF MEETING


The February meeting of MIFDI was cancelled due to a family emergency with our presenter. We apologize for this cancellation.
