

### SCHEDULE:

### **DIRECTIONS:**

FROM RT.128/I 95: Take Rt. 20 West to Rt. 27 in Wayland. Turn right on Rt. 27 and continue until Rt. 27 makes a right towards Maynard, *DO NOT TURN RIGHT*, continue straight for aprox 3-miles and the Academy will be on the right.

FROM RT. 495 North: Take Rt. 85 (Exit 25) towards Hudson. At the traffic light turn left onto Rt.85. Turn right on Broad St. (First traffic light), and at the second traffic light turn right on Rt.62. Continue straight until Rt. 62 takes a left towards Stow, *DO NOT TURN LEFT*, continue straight for aprox 4-miles and the Academy will be on your left.

FROM RT. 495 South: Take Rt.62 (Exit 26) into Hudson Center. Continue halfway around the rotary and continue on Rt.62 East. Continue straight until Rt.62 turns left towards Stow, *DO NOT TURN LEFT*, continue straight for aprox 4-miles and the Academy will be on your left.

The training was provided by Cliff Plourde of IPP/IPS. Cliff offered members an informative presentation on the latest options and technology in detection equipment for the fire service. # Page 5 **EMS Run** Eastern Equine Encephalitis

Hopefully by the time you read this the threat of EEE will have subsided, however as of the first week of September, a 7<sup>th</sup> human case of EEE has been reported. The risk level has been increased to "Critical" in the communities of Ashland, Hopedale and Milford.


According to the CDC, the incubation period for the Eastern Equine Encephalitis Virus (the time from the infected mosquito bite to the onset of illness) is 4-10 days. EEV can result in one of two types of illness, systemic or encephalitic (involving swelling of the brain). The type of illness will depend on the age of the person and other host factors. It is possible that some people who become infected with

EEEV may not develop any symptoms.

System infection has an abrupt onset and is characterized by chills, fever, malaise, arthralgia and myalgia. The illness lasts 1-2weeks and recovery is complete when there is no central nervous system involvement. In infants, the encephalitic form is an abrupt onset, in older children and adults the encephalitis is manifested after a few days of systemic illness. Signs and symptoms in encephalitic patients are fever, headache, irritability, restlessness, drowsiness, anorexia, vomiting, diarrhea, cyanosis, convulsions, and coma.

Approximately a third of all people with EEE die from the disease. Death usually occurs 2-10 days after onset of symptoms but can occur much later. Of those who recover, many are left with disabling and progressive mental and physical deficits which can range from minimal brain dysfunction to severe intellectual impairment, personality disorders, seizures, paralysis, and cranial nerve dysfunction. Many patients with severe deficits die within a few years.

There is no vaccine against EEEV infection or antiviral treatment. Patients with suspected EEE should be transported and evaluated for appropriate diagnostic testing and supportive treatment.

### INSTRUCTORS CORNER: 2019 Hurricane Season

June 1 marks the beginning of the 2018 Atlantic hurricane season which ends on November 30. Hurricanes are massive storms that form over warm ocean waters and move toward land. Potential threats from hurricanes include powerful winds, heavy rainfall, storm surges, coastal and inland flooding, rip currents, tornadoes, and landslides.

Hurricanes can happen along any U.S. coast or in any territory in the Atlantic or Pacific oceans. They can affect areas more than 100-miles inland and are most active in September.

Storm surge is caused by ocean water that is pushed toward the shore by the force of the winds. It is fast and can produce extreme coastal and inland flooding. Hurricane storm surges can produce over 20-feet of water pushing towards the shore and several miles inland destroying property and endangering lives. Storm surge is historically the leading cause of hurricane deaths in the U.S. Water weighs 1700 pounds per cubic yard so battering waves from a surge can easily demolish buildings and cause massive destruction along the coast. Storm surges can undermine roads and foundations of buildings causing potential for collapse.

PRESIDENTS NOTE: As firefighters, we are not immune to damage to our own home during major storms, we saw that in New Orleans. Secure your property and train your family to be prepared to deal with storms when you are on duty. We cannot just leave work early like the private sector; these are the days that we are needed the most! Keep an emergency preparedness kit in your basement along with bottles of water, flashlights non-perishable foods, batteries, etc. You should always keep your station locker stocked with extra clothes, cans of soup and other essential items in the event you are held over for additional tours.
