




The Massachusetts Institute of Fire Department Instructors offer our condolences to the family and friends of the following firefighters that died in September;

**Presidents Note**: After hearing about this horrific incident, my thoughts were, "this could happen to any department". We respond to gas calls all the time and with winter on the way we can expect more of these calls due to heating systems malfunctioning and ground frost causing cracks n the street piping. We should never become complacent, nothing is routine.

- Always wear PPE when investigating inside gas odors.
- Your dispatcher should notify the gas company immediately
  after sending apparatus. They often have an extended ETA and
  you can always cancel them if it determined that they are not
  needed.
- Building maintenance people can be very helpful with locating utilities and shut-offs but remember that they have no protective equipment if something goes wrong.
- Use a limited amount of members during the investigation and always have someone outside to call for additional resources if things turn bad.
- It is good to use more than one CGI if available in the event that the calibration is off.
- Gas seeping through dirt can cleanse the odorant. You must rely on your CGI for readings.
- Avoid parking the engine directly at the front door. Treat it like a structure fire and park beyond the building.
- When venting a gas filled building, evacuate all members BEFORE the gas reaches the flammable range. That is the <u>most dangerous</u> time of the incident.
- Avoid the habit of turning on a light switch when entering a dark gas filled structure and do not transmit on your portable radio inside, leave the building to give a report.

#### **INSTRUCTORS CORNER:**

#### **Propane Explosion in Maine**

On September 16, 2019, Farmington ME firefighters responded to a gas odor in the LEAP Center (Life Enrichment Advancing People). The building maintenance supervisor noticed that the previously full 400-gallon outdoor propane tank was empty and he could smell an odor of propane. Firefighters arrived to investigate with the maintenance supervisor just prior to the explosion.

The blast was heard for miles and totally destroyed the building leaving a large debris field. The explosion killed Captain Michael Bell and injured six others including Captain Bell's brother, Chief Terry Bell. As of this writing, Chief Bell and another captain remain hospitalized at Maine Medical Center. The maintenance supervisor remains in critical condition at Mass General Hospital. Three other injured firefighters have been treated and released. Investigators continue to determine what caused the leak in the underground propane line and what the ignition source was that triggered the explosion.
