



# <u>EMS RUN</u> Flu Season

The 2023-2024 flu season is now underway. According to the CDC, the flu season in the United States is from October to March. Many people think of the flu as a seasonal nuisance that everyone tries to avoid. Seldom is it thought of as life-threatening except for the elderly or those with weakened immune systems, usually associated with other medical issues.

Flu symptoms usually present with the following:

Fever of feeling feverish associated with chills Cough Sore throat Runny or stuffy nose Muscle or body aches Fatigue Some may experience vomiting or diarrhea (more common in children)

Below are some basic rules for EMS incidents involving flu patients;

Transport the flu patient with any of the following symptoms;

Breathing problems

- Difficulty keeping fluids down
- Fever that will not break
- Appearing to get better only to have fever go up again
- Change in mental status
- Underlying medical conditions

Remember to protect yourselves when responding on an EMS run with a patient experiencing flu symptoms. Use the N95 mask for you and apply one on the patient.



## **INSTRUCTORS CORNER**



It is interesting to see deck guns/ stacked tips being used at massive fires where they have lots of water and firefighters don't remove the extra stacked tips. The difference in reach is small but the flow is doubled from the small to the large. Unless you are specifically trying to have less water application (weight/collapse implications on a fire damaged building) use the big tip!
