

MEETING NOTICE

The next meeting of MIFDI will be held on <u>Wednesday, March 27,</u> <u>2024.</u> We will be hosted by the Massachusetts Department of Fire Services and the Massachusetts Firefighting Academy courtesy of State Fire Marshal Jon Davine. We last met at the fire academy for our March 2023 meeting. (We are scheduled to meet in Classroom 125, however, check the welcome screen in the lobby in the event of a room location change).

We will be greeted by Deputy Fire Marshal Maribel Fournier and the new MFA Director Eric Littmann to offer some visions and updates on the DFS and the MFA . The training will be an overview of the ASHER Program created to assist firefighters and other agencies with dealing with Active Shooter Hostile Event Response in this new world of increased violence.

SCHEDULE:

0900: Coffee (Available in the cafeteria), **1000:** Presentation, **1130:** Business meeting, **1200:** Lunch.

DIRECTIONS:

FROM RT.128/I 95: Take Rt. 20 West to Rt. 27 in Wayland. Turn right on Rt. 27 and continue until Rt. 27 makes a right towards Maynard, *DO NOT TURN RIGHT*, continue straight for aprox 3-miles and the Academy will be on the right.

FROM RT. 495 North: Take Rt. 85 (Exit 65A) towards Hudson. At the traffic light turn left onto Rt.85. Turn right on Broad St. (First traffic light), and at the second traffic light turn right on Rt.62. Continue straight until Rt. 62 takes a left towards Stow, *DO NOT TURN LEFT*, continue straight for aprox 4-miles and the Academy will be on your left.

FROM RT. 495 South: Take Rt. 62 (Exit 67) into Hudson Center. Continue halfway around the rotary and continue on Rt.62 East. Continue straight until Rt.62 turns left towards Stow, *DO NOT TURN LEFT*, continue straight for aprox 4-miles and the Academy will be on your left.

Ample parking is available in the upper-lot on the "D-Side" of the MFA campus.


